COVID-19 tests are shallow nasal swabs, which are quick and painless, and will be self-administered under observation by your informed consent for the above-named individual to be able to participate in diagnostic and screening COVID tests.

INDIVIDUALIZED DIAGNOSTIC and SCREENING TESTING PERMISSIONS (Rapid Antigen Tests and/or Molecular Tests [reaction] Tests)

- I understand that Renton School District is providing individualized diagnostic testing in the event of COVID-like related to exposure to a COVID positive individual.
- Testing will be self-administered or with the assistance of a parent/guardian and observed by trained school personnel.
- I understand and acknowledge that a positive COVID-19 test result is an indication that the above-named individual may be infecting others.

COVID-19 TESTING PERMISSIONS

- I understand that false positive or false negative COVID-19 test results may occur. Due to the potential for a false positive, the above-named individual should continue to follow all COVID-19 safety guidance, including mask-wearing and public health protocols for isolating and testing in the event the above-named individual develops symptoms.
- I understand that the personnel observing diagnostic and screening testing have received appropriate training.
