



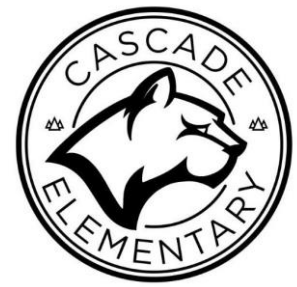

Dear Cascade Community:

One of the most important aspects of our school is the extent to which our parents are involved in the life of the school. This may come in the form of volunteering in the classroom, attending a school event, chaperoning a field trip, or participating in the fall parent-teacher conference.

Our music teachers, Ms. Alley and Ms. Anderson, have been working with students to prepare for this event. We invite all parents, grandparents, family and friends who are current or former members of the armed forces to be honored at this assembly.

Payments can take up to 24 hours to post to the child's lunch account or field trip account.

What is Title I?

Title I, Part A of the Elementary and Secondary Education Act (ESEA) provides financial assistance to states and school districts to meet the needs of educationally at-risk students. The goal of Title I is to provide extra instructional services and activities which support students identified as failing or most at risk of failing the state's challenging performance standards in mathematics, reading, and writing.

District Parent Involvement Policy

The Renton School District values parental involvement in students' education and has a Parent Involvement Policy (No. 4130) to support this value. The Categorical Programs Department holds annual parent advisory meetings for Title I, LAP, and ELL parents to gather feedback and implementation suggestions on the district's parent involvement policy, procedures and programs. The District's policy is available on the district website and at the front desk in each school. School parent involvement plans are made available to parents at conference time and through school newsletters.

Instruction by Highly Qualified Staff

In compliance with the requirements of the Every Student Succeeds Act (ESSA) we would like to inform you that you may request information about the professional qualifications of your student's teacher(s) or instructional paraprofessional(s).

Citizens Complaint Process

When a District receives Federal Title I funds it allows us the opportunity to provide supplemental support programs for Title I eligible students. As a recipient of these funds we are required to inform you that if you have a complaint about the services offered under Title I and have not been able to resolve them through the District process, you may file a citizen complaint to the Office of the Superintendent of Public Instruction (OSPI).

A citizen complaint is a written statement that alleges a violation of a federal rule, law or state regulation that applies to a federal program.

- Anyone can file a citizen complaint
- There is no special form

There is no need to know the law that governs a federal program to file a complaint



¿Qué es Title I?

Title I, Parte A del Acto de la Educación Primaria y Secundaria (ESEA) proporciona la asistencia financiera a los estados y distritos escolares para cumplir con las necesidades de los estudiantes educativamente en riesgo. La meta de Title I es proporcionar servicios y actividades educativas extra, los cuales apoyan a los estudiantes que han sido identificados como que están reprobando o bajo el mayor riesgo de reprobación los exigentes estándares de rendimiento en matemáticas, lectura y escritura del estado.

Norma del Distrito Sobre la Participación de los Padres

El Distrito Escolar de Renton valora la participación de los padres en la educación de los estudiantes y cuenta con una Norma Sobre la Participación de los Padres (No. 4130) para apoyar este principio. El Departamento de Programas Categóricos lleva a cabo reuniones anuales de asesoría por parte de los padres dentro de los programas Title I, LAP e ELL, para recopilar retroalimentación y sugerencias de implementación sobre la norma, los procedimientos y programas de participación de los padres. La norma se encuentra disponible en el sitio de la red del distrito y en la recepción de cada escuela. Los planes para la participación de los padres en la escuela se ponen a su disposición durante las conferencias y a través de los boletines escolares.

Proceso de Denuncias Ciudadanas
